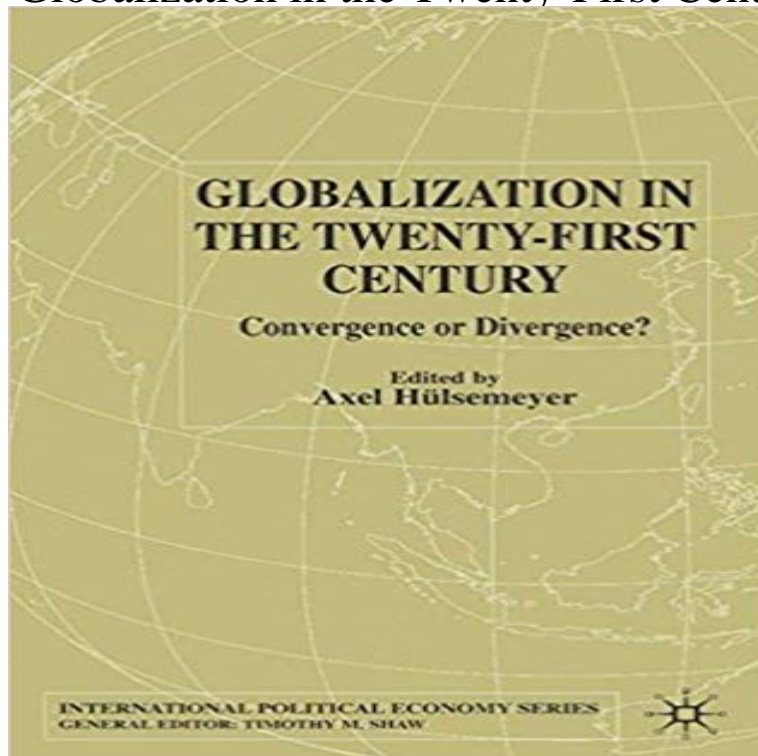


Globalization in the Twenty-First Century: Convergence or Divergence?
