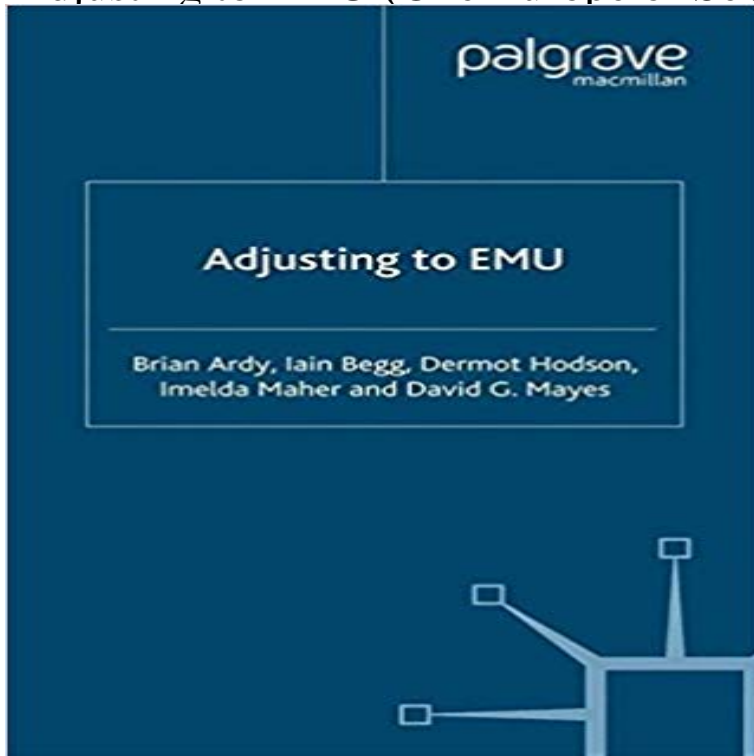


## Adjusting to EMU (One Europe or Several?)
