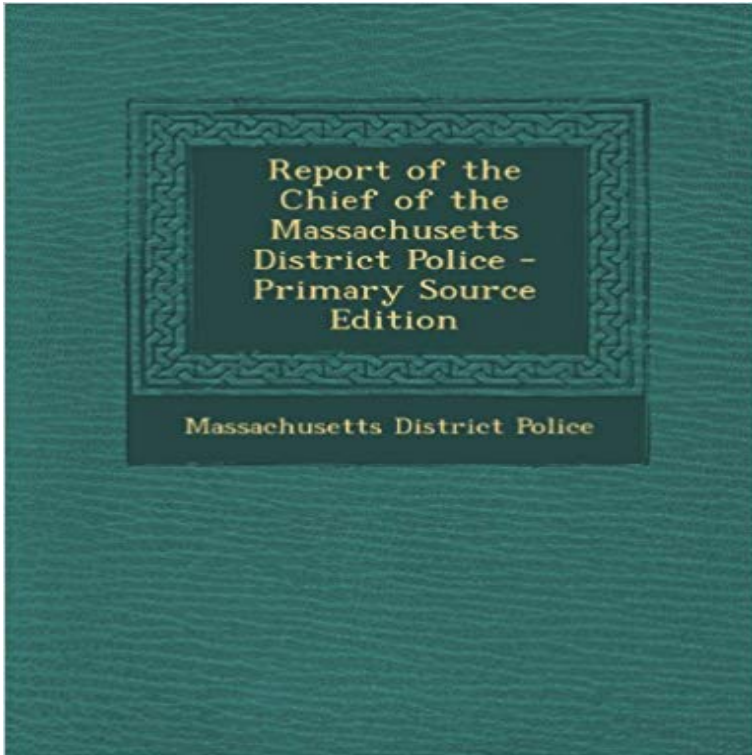


Report of the Chief of the Massachusetts District Police - Primary Source Edition
